By the time you read this, the 9th New England Regional Genealogical Conference in Hartford, Conn., will be history. I hope all who attended had a good time, learned much and had a chance to network with kindred souls. We are now looking forward to the summer and Vermont History Expo, where GSV will once again have a presence. For those of you who are in Vermont in late June, this is an event not to be missed. Approximately 100 historical societies and a number of genealogical societies from around the state will

have exhibits of interest and relevance to family historians. Auctions, musical entertainment, and more make for an entertaining, educational and fun event for all ages. We are still interested in recruiting someone to handle GSV publication sales. That task is currently being handled by your President. Although not a daunting job, it is

still true that many hands make work light, and we would like to spread the work around as much as possible. To give you an idea of the demands of the job, we have received 39 publication requests since the annual meeting in October. That's about 10 per month. When a request is received, the publication is sent out to the requester, and the check is sent on to our Treasurer. Occasionally (typically with libraries) a request comes in without money, and the books are then sent out with an invoice.

NGS Contests and Awards

The 103 year old National genealogical Society sponsors a number of contests and awards for both beginning and experienced genealogists. Given the range and variety of opportunities for recognizing skills and achievements through the National Genealogical Society I'm sure we must have at least one person or organization we feel deserves a nomination for their contributions to genealogy. Note the deadlines on many of the awards have just passed

(March 1). Plan ahead to be able to submit nominations in a timely manner. Additional information and forms are available at the NGS website—www.ngsgenealogy.org.

Awards are offered in the following categories:

Award for Excellence—Genealogical Methods and Sources. Given for a "specific, significant single contribution in the form of a book, an article or a

series of articles published during the last 5 years that discusses genealogical methods and sources and serves to foster scholarship and/or otherwise advances or promotes excellence in genealogy." Deadline is March 1.

Family History Writing Contest. Only open to NGS members. Deadline is January 31.

The finances of GSV are still a hot topic among your board members. Treasurer Jane Belcher has brought herself up to speed rather quickly in her new job and has made a number of suggestions for improving our financial picture. Don't panic. We are not about to fold, but we are running a deficit, and are interested in finding out how to get out of that mode. The dues increase instituted in 2006 was a badly needed component of a solution, but we still need to do more. As it stands, the dues we collect barely cover the costs of Vermont Genealogy and the Newsletter that each member receives. Our twice-yearly conferences have been money losers for us as we have attempted to keep costs down for our members. We are looking for ways to continue holding our conferences

without sacrificing quality, but without straining the pocketbooks of attendees, too.

Suggestions that some have made include having only one conference per year, further modifications to our dues structure, and placing Vermont Genealogy and/or the Newsletter online for those who elect to do so. This latter approach is being instituted by the Connecticut Genealogical Society, and they have developed a rather complex dues structure to "reward" those who choose electronic receipt of their publication "The Nutmegger". We have come to no conclusions on what steps to take to improve our position, and are welcoming suggestions from you, the members.

Our Website Chair, Diantha Howard, has made great progress in developing a section of our website (www.genealogyvermont.org) to display Vermont-related genealogical content. We are gradually scanning and adding issues of Branches and Twigs to our website, at the rate of at least one volume per month. Because of the typeface used in the publication, attempts to create pdf files that would allow full search capabilities have failed. Accordingly, we are trying to provide you with the best quality images of

the issues, and have provided indexes for each volume as well. When the entire series is posted, a single index covering all of the 24 years is planned to be provided. As always, we welcome your suggestions and comments for improving the website, and if you have Vermont-related content that you would like to contribute to the site, we would be happy to hear about that, too. We are interested in vital records, cemetery listings, compiled town records, family bible records, etc. We want the website to be of interest and value to our members.

GSV bylaws have not been adjusted for a few years, and they are currently undergoing review and modification to reflect current times and current operations. We hope to have changes ready for a vote by the membership at our Fall meeting.

Here's a wish for a productive summer of research for all members. We look forward to hearing from you, and to seeing many of you at Vermont History Expo in June, and at our October membership meeting and conference. Details on that meeting will be coming in the next Newsletter.

New England Abenaki History and Genealogy Available Online

If you have American Indian ancestry in Northern New England or northern New York, you may be interested in Ne-Do-Ba, an organization dedicated to the Abenaki of Western Maine. Ne-Do-Ba, which means friends, is a nonprofit organization that focuses on "history,

culture, community, family and self." While the web site's home page specifies that it covers "topics relating to the Abenaki Indian and their Euroamerican relationships in Western Maine, "I found a lot of information about Abenaki Indians in New Hampshire, Vermont, and New York as well.


Genealogy documents on the site include the March 25, 1858 census of the Penobscot Indians as taken by school supervisor J. C. Knowlton. The transcribed census is at http://www.avcnet.org/ne-do-ba/cen_p58.html. Another section is

named "Wabanaki Warriors of the Past" and is divided into eras such as the Revolutionary War, the War of 1812, and the U.S. Civil War.

Information listed for each person named includes military data and tribe of origin, where known.

I was also fascinated by the story of the Great massacre of 1694 at Oyster River, now known as Durham, New Hampshire. The article describes the battle from the points of view of both sides.

Dating Questions

One habit that continued and today can be confusing was a type of shorthand for four of the 12 months. What modern month do the following abbreviations correspond to: 7ber, 8ber, 9ber, and 10ber?



and Family History Book.

Awarded for a "significant, single contribution in the form of a family genealogy or family history book published [in] the last five years."

Award of Merit. Given for outstanding work in American genealogy to an individual or organization. The website states "awards to individuals or institutions who, over a period of five years or more, have made outstanding contributions to the Society's programs or who have performed outstanding work in the field of genealogy, history, biography or heraldry." NGS membership is not necessary.

Award for Distinguished Service. This is given to individuals to recognize their dedication to the work of the NGS.

Honorary Individual Membership. Honorary Membership is awarded to those that have made outstanding contributions to the field of genealogy or NGS. NGS

membership is not required for this award, the equivalent of NGS Life Membership.

Honorary Organization Membership. This is given to organizations that demonstrate a history of "outstanding contributions to the Society's programs or have performed outstanding work in the field of genealogy, history, biography or heraldry."

NGS Fellow. Recognizes work in genealogy, history, biography or heraldry as well as exemplary service to NGS. In order to qualify a nominee must be a NGS member for at least five years.

Rubincam Youth Award. The youth award is open to students in grades eight through 12 that submit the best prepared genealogy. The award includes a one year NGS membership, \$500.00 cash award, and a certificate recognizing their accomplishment. Deadline: before March 1.

National Genealogy Hall of Fame. One person is admitted to

the National Genealogical Hall of Fame each year. The award recognizes the educational contributions by an individual to the high standards in history, awareness of and appreciation of genealogy.

The Filby Prize for Genealogical Librarianship. Nominees must be a librarian with at least five years experience in a public, academic or special library with a focus on genealogy and local history. Other criteria include publication of a book or body of articles that have contributed significantly to the field of genealogy or local history; improved patron access or record preservation (more criteria are listed at the NGS website, see the NGS contact box.) Deadline: by April 1.

Genealogical Newsletter Competition. This is designed to "recognize the hard work, long hours and creativity" given by editors of genealogical newsletters. Categories include family associations, County or local genealogical or historical societies, and major genealogical or historical societies. Applicants must be a member of NGS and submissions are entered by the organization, not individuals. Deadline: December 31.

Rutland County, Vermont Probate Extracts, Part II

The third of five planned extracts of Rutland County Probate Records has been released. Compiled by Margaret R. Jenks, Danielle L. Roberts, Dawn D. Hance, the authors have abstracted every item and entry in Volumes 1-8, 9-12 and 13-16 of the Rutland County, Rutland District probate records. The sixteen volumes cover the period from the establishment of the Probate Court to October 1827. All items of genealogical interest have been included in the extract: wills, inventories, administrator's accounts, receipts, petitions, guardianship, and other data pertaining to the probate of an estate.

Since it often took many years to settle an estate many of the estates in the second volume of extracts were initiated in the first vol-

ume. Likewise, some estates first reported in the second volume will be continued in succeeding volumes.

Dawn Hance, Rutland Historian, has checked the original material at the court house in cases where the microfilms are illegible or pages were not filmed. Her extensive knowledge of the area has added much detail to the extracts. Her experience in extracting the Rutland Herald and other early area newspapers has added useful information.

The five volume project is expected to continue the extracts to about 1850 when full names appear in the Federal census records.

Probate records for the Fair Haven District are also being compiled.

Unfortunately two fires have plagued the Fair Haven District. The first two volumes were lost in a fire about 1797. A second fire in 1862 burned all of the Poultney vital records, deeds, town records, and eight volumes of probate records in the period from 1807 through 1842 (not all probate records were lost, just volumes 7, 9, and 12 through 18.).

This second volume covers 107 families, has improved formatting and more complete information on the third generation of early Vermonters.



Research Contest Answer

The research question posed in the last issue had no winner. The question was: What is the oldest charitable society in the United States, and why would a genealogist want to know this?

The Scots' Charitable Society is the oldest (350 years) non-church charitable society in the United States, and probably the Western Hemisphere. The society was founded in Boston in 1657 to aid Scottish emigrants or travelers that needed assistance—medical, burial, or travel help to return to Scotland.

This is useful to the genealogist because the original records from

1657 still exist. The originals are not available for use but the material was microfilmed about 1980. The film is on deposit at the New England Historic Genealogical Society in Boston. Any one with early Scottish ancestors in the Boston area may find these records helpful.
