RANDOLPH CENTER - Miriam "Mim" Herwig, 91, passed away peacefully on May 29, 2015, at Dartmouth-Hitchcock Medical Center, with family members by her side.

She was born on June 30, 1923, in Barre, Vermont, to Earl and Mildred (Farr) Boyce of Williamstown, Vermont, where she grew up on the family farm. She graduated as the valedictorian of Williamstown High School in 1941, and was the salutatorian of the class of 1943 at Vermont Junior College in Montpelier.

Mim worked for National Life in Montpelier before marrying Wesley Herwig of New Britain, Connecticut, on May 18, 1946. The two had become acquainted as contributors to a youth section in the Rural New Yorker publication. The couple settled in the Randolph area, moving into their stately Randolph Center home in 1950 where Mim and Wes raised their family.

Mim was a gifted writer who wrote several books besides editing and publishing over 40 books for others through Greenhills Books, a business she and Wes conducted. She served as a local newspaper correspondent and weather columnist as well. A respected historian, she delivered many talks about historical events and championed numerous related projects including the establishment of historic districts, the erection of markers, and the restoration of buildings.

An active member of the community, Mim's affiliations included membership and offices in the Vermont Historical Society, the Randolph Historical Society, the First Congregational Church of Randolph Center, the Poetry Society of Vermont, the Mayflower Society, the Vermont Old Cemetery Association, the Randolph Planning Commission, the World's Fair Association, the Hilltop School Club, the Home Demonstration Club, 4H and youth leadership. She was a charter member of the Winterhaters' Club. She was honored as a WCAX "Super Senior" and received a "Successful Aging" award from the Central Vermont Council on Aging. Mim enjoyed flower and vegetable gardening, poetry, bird watching, baking, sewing, sliding, bike riding, compiling scrapbooks, hosting family gatherings, playing the piano and organ, and sharing her wealth of knowledge with others. For many years she played the organ in the "antique cabin" at the Tunbridge Fair.

Survivors include daughters Merrilee McTighe and R. Lee Collette, of West Townsend, Massachusetts; Trudy and Bill DeFlorio, of Randolph Center; Daphne Herwig, of East Roxbury; Christy Herwig, of Randolph; Holly and Jody Benoir, of Braintree; seven grandchildren; two step-grandchildren and six great-grandchildren, as well as two nephews. Mim was predeceased by her husband, Wes, in 2003, and brother, Robert Boyce, in 2014.

Calling hours were from 5-7 p.m. on Saturday, June 6, at Day Funeral Home in Randolph. A memorial service was held on Sunday, June 7, at 1 p.m. at the Randolph Center Church. WRITING HOME TO VERMONT DURING THE CIVIL WAR, PART 2

Mrs. George Temple of Randolph, Vermont received an envelope postmarked in Washington, D.C. circa 1863.[Figure 4] An Elizabeth (apparently Mrs. George) Temple, with six month-old “Howard G.,” is in Randolph in the 1860 U.S. census.^[15] George Temple served as a private and later corporal with the 10th Vermont Infantry, and this regiment was in the Washington, D.C. area from September 1862 until June 1863.^[16] George Temple died of disease on 22 February 1864.^[17] Elizabeth Temple filed for a widow's pension on 28 March 1864, and she is with her apparent ten year-old son George H. Temple and late husband's parents in Randolph in the 1870 U.S. census.^[18] The envelope is illustrated with a soldier and a woman embracing.




Figure 5 (1864) envelope from Emory Hospital in Washington, D.C. to Johnson, Vermont (Photo courtesy of James W. Milgram, M.D., *Federal Civil War Postal History*, p. 301).

Mark French of Johnson, Vermont received an envelope and letter from Emory Hospital in Washington, D.C. postmarked on 21 July 1864.[Figure 5] Mark and Mary French, their apparent sons James F. and Jason O. French, and three other children are in Johnson in the 1860 U.S. census.^[19] An enclosed letter states that Jason is “in the best of spirits though he is verry low and week,” that a nurse stated that Jason “is the tuffest man that you ever saw [following a wound to his liver],” and is signed “your loveing son & brother J.F. French.”^[20] James F. French served as a private with the 5th Vermont Infantry, and this regiment was in Washington, D.C. in mid-July 1864.^[21] Jason O. French served as a private with the 17th Vermont Infantry, and he was wounded in June 1864 at the Battle of Cold Harbor.^[22] James F. French survived the war, and lived until 1911.^[23] Jason O. French survived the war, married Lizzie M. Potter in Cambridge in 1881, and lived until 1913.^[24]

Reverend H.O. Higley of Castleton, Vermont received a “Prisoner of War Letter” postmarked at the Union-




Figure 6 (1864) "Prisoner of War Letter" from the Marine Hospital in Charleston, South Carolina via Port Royal, South Carolina to Castleton, Vermont (Photo courtesy of Robert A. Siegel Auction Galleries, Sale 988, Lot 221)

Confederate exchange point of Port Royal, South Carolina on 20 August 1864.[Figure 6] Hervey O. Higley, a Congregational clergyman, and his apparent son Edwin H. Higley are in Castleton in the 1850 U.S. census.^[25] Edwin H. Higley served as a private and later as lieutenant and captain with the 1st Vermont Cavalry, the same regiment as William N. Buck.^[26] Edwin H. Higley was wounded and taken prisoner in June 1864.^[27] The envelope was sent from the Marine Hospital in Charleston, South Carolina, where the prisoners were at risk during bombardment.^[28] An enclosed letter written 2 August 1864 states that “we moved from Macon last week and arrived here yesterday...There are six hundred prisoners here—all officers.”^[29] Edwin H. Higley survived the war, married Jane S. Turner in Middlebury in 1870, and lived until 1916.^[30]

This article shows how postal history adds to our knowledge of our ancestors' wartime experience. Other Vermont envelopes and postcards illustrate our ancestors' work, family correspondence, travel, political and social interests, where an ancestor lived before emigrating to the U.S., and may have their photograph on a real photo postcard.^[31] Postal history vendors have given *Philgen.org* permission to use thousands of photographs from their websites and archived auction catalogs and most have not yet been placed on *Philgen.org*. At present, genealogists cannot easily locate an envelope or postcard sent or received by their ancestors. Envelopes for

sale and in postal history collections are classified by stamps, cancellations, and other postal markings, and postcards are grouped by the location or theme on the front of the postcard. The purpose of *Philgen.org* is to classify envelope and postcard photographs by who wrote and received each one to make them accessible to genealogists. Anyone interested in adding Vermont envelopes and postcards to the website is invited to contact the author. Photographs and data posted for each item will be credited to the person and/or their genealogical or philatelic association.

Vermont Families in 1791, Vol. 2. Scott A. Bartley, ed., 1997, 304 pp., hardbound. Item No. GSV 5; \$27.00 members, \$30.00 non-members. This second volume covers 107 families, has improved formatting and more complete information on the third generation of early Vermonters.

Vital Records of Putney, Vermont to the Year 1900. Compiled and edited by Ken Stevens, 1992, 406 pp. Item No. GSV 2; \$27.00 members, \$30.00 non-members. This is a complete compilation from all primary sources available in the town. This is augmented by the ministerial records of the pastors who served as early as 1776.

Vital Records of Rockingham, Vermont and the Records of the First Church of Rockingham. Reprinted from the 1902 and 1908 first editions, newly indexed by Christopher T. Norris and Scott A. Bartley, 323 pp., hardbound. Item No. GSV 3; Reprinted from the first editions of 1908 and 1902, this is an important source of one of Vermont's oldest towns. The town records extend to 1845 and church records from 1773 to 1839. New to this edition is an indispensable index of nearly 1,000 names. *out of print.*

Windsor County, Vermont Probate Index, 1778-1899. Scott Andrew Bartley and Marjorie-J. Bartley, compilers, 2000, 560 pp., hardbound. Item No. GSV 6; \$45.00 members, \$50.00 nonmembers. This is a comprehensive index of all files in the Windsor County Probate Court Districts —Windsor and Hartford. The records cover the period from the earliest 1778 records through the end of the nineteenth century, more than 20,000 probate files. The files are indexed by the name of the major party in the case, place of residence, probate district, type of record, year, and probate record volume .

Index to Branches & Twigs, 1972—1995. Robert M. Murphy, ed. 2000, 572 pp., hardbound. Item No. GSV 7; \$58.50 members, \$65.00 nonmembers. This is the every-name index to GSV's Branches & Twigs, published for 24 years in 96 issues. The 180,000 entries include every genealogically important name mentioned in every issue. Separate sections of this work list the coverage of each Apple Orchard installment, and provide a full author and title index to book reviews. Branches & Twigs included large quantities of information of interest to family historians.

Sudbury, Vermont: Genealogies, Vital Records, and Census Records. Mary Ann Z. Wheeler, 2000, 416 pp., hardbound. Item No. GSV 8; \$44.55 members, 49.50 nonmembers. This book is a comprehensive transcription of census and vital records for Sudbury, plus carefully compiled genealogies of families. This book is among the very best genealogical resources about a Vermont town. This is a cooperative publication between GSV and Picton Press.


