PRESIDENT'S MESSAGE

Vermont has now passed 24,300 cases of COVID-19, resulting in 256 deaths. However, there is light at the end of the tunnel. The daily positivity rates are down (many days into the single digits) and 96% of the cases have fully recovered. Governor Scott announced that the state's pandemic restrictions can be lifted ahead of the Vermont Forward target date of July 4th — if the state vaccination rate reaches 80% of eligible Vermonters. As of this writing, the state is just 8,000 vaccinations shy of that goal. Therefore, after not holding a membership meeting in 2020 due the pandemic, GSV is planning an in-person meeting in the fall of 2021. The details will be in the next Newsletter and on the GSV website for the location and speakers, etc. It will nice to see many familiar faces after an absence of two years.

The 16th New England Regional Genealogical Conference (Virtual NERGC 2021), was held over the course of 61 days in April and May. The conference was a success, due to the hard work of the countless volunteers from the member societies of the consortium. I served as the chair of the Newsletter Committee, which was responsible for the creation and distribution of the 10 weekly NERGC Newsletters. Plans are already underway for next NERGC, which may include some hybrid aspects. The next conference will be held May 4-6, 2023 at the MassMutal Center in Springfield, Massachusetts. This location provides space for at least 7 lectures at a time, in addition to a Exhibit Hall, and an area for dining events. More information will be available as we approach the 2023 conference.

This Newsletter includes a belated obituary of Barbara Mae (Bullock) Jones, who died in Burlington, on December 25, 2020. Barbara was a longtime member of GSV and a former resident of Charlestown, N.H. Her obituary was not available at the time of the publication of the last Newsletter, so we are including it now. [see page 4 for the complete obituary] We must also note the passing of Mary Choppa of Nashua, N.H., on April 26, 2021. Mary was the TIARA [The Irish Ancestral Research Association] delegate to NERGC and served as the NERGC Volunteer Chair for the 2015, 2017, and 2021 conferences. She was a NERGC Conference Chair in 2019. Based on her many contributions to both TIARA and NERGC, she was the recipient of NERGC's Donna Holt Siemiatkoski (DHS) Volunteer Award in 2019. Both of the these ladies will be certainly be missed by the genealogical community.

State Vital Records Registry

Since 1779, town clerks have been mandated to record all births, deaths, and marriages that occurred in their towns; however, vital events were not recorded at the state level until 1857.

1857: Annual reporting by town clerks

Act No. 63 of 1856 created the Vermont Vital Registry System, which required town clerks to compile lists of the vital events that occurred in their respective towns during the course of a year starting in 1857.

Lists of town vital events were initially submitted to the Vermont Secretary of State on an annual basis and bound by year and town. To understand what was initially recorded for births, marriages, and deaths, see Instructions concerning Registrations in the State of Vermont that were issued by Secretary of State Benjamin W. Dean in 1859.

1898: Divorces added to state registry

In 1896, the Vermont legislature passed Act No. 56, which required county clerks to submit the number of divorces granted, and their cause, to the State Board of Health for statistical purposes only. Returns of divorces were eventually added to the State Vital Registry by Act No. 59 of 1898.

1902: Semi-annual reporting starts and State Board of Health starts maintaining statistics

Act No. 114 of 1902 required town clerks to transmit returns of births, marriages, and deaths to the State Board of Health semi-annually (in March and September). The State Board of Health was charged with preparing and publishing tables (vital statistics) and transmitting the returns from the town clerks to the Office of the Secretary of State for "indexing, binding and preservation."

In 1904, the Vermont legislature passed Act No. 140: An Act Related to the Registration of Births, Marriages, Divorces, and Deaths. Through this act, town clerks were responsible for transmitting returns of births, marriages, and deaths to the State Board of Health every six months (in January and June). Relative to divorces, county clerks were responsible for submitting returns of divorces to the State Board of Health every six months. Returns were submitted to the Office of the Secretary of State.

1908: Monthly reporting for births, deaths and marriages only; card index created

Four years later, in 1908, Act 78 was passed. This legislative act required all town clerks to submit certified copies of

all births, marriages and deaths to the State Board of Health on a *monthly* basis. These returns continued to be transmitted to the Office of the Secretary of State for "indexing, binding and preservation."

Through Resolution No. 425 of 1908, the Secretary of State was authorized to create a card index for any records in the custody of the Secretary. This included the annual lists of vital events had been submitted to the Secretary by town clerks and the vital returns. Unfortunately, relative to the Vital Registry, not all towns complied with the above laws and the registry within the Office of the Secretary of State was considered incomplete.

1919: Town clerks required to transcribe all vital events recorded in their respective towns

As a result, in 1919, the Vermont Legislature passed Act No. 92, which required all town clerks to transcribe, in full, records of births, marriages, and deaths in the possession of the town and churches. In addition, inscriptions of gravestones for all individuals who died prior to 1870 needed to be transcribed as well. The town select boards were responsible for paying transcribers five (5) cents per card and transmitting all cards to the Office of the Secretary of State by January 1, 1920.

The requirement to transcribe records and transmit the copies to the Office of the Secretary of State was reintroduced again in 1921 by Act No. 89. Towns who had failed to transcribe their records and transmit them to the Office of the Secretary of State by July 1, 1921 risked having their records "procured" by the Office of the Secretary of State at the expense of the town. Legislative acts concerning amendments to vital records (i.e. to correct errors in spelling or add additional information) did not get introduced until the late 1930s.

1980: Act to Modernize and Improve Laws Relating to Vital Records is passed

Several changes to the forms, filing and transmittal requirements between town and county clerks and the State Board of Health and, later, Department of Health were enacted between the 1930s and 1980. In 1980, Act 142 (An Act to Modernize and Improve Laws Relating to Vital Records) was passed. Subsequent to this act, the vital records within the Office of the Secretary of State were physically removed and divided between the Vermont Department of Health and former Department of Public Records, which operated the State Records Center.

2008: Vermont State Archives and Records Administration created

This arrangement remained in place until July 1, 2008 when the now Division of Public Records (within the Department of Buildings and General Services) merged with the Ver-

mont State Archives to create the Vermont State Archives and Records Administration, which is a division of the Office of the Secretary of State. At that time, all vital records in the state registry dating from 1909 and later stored in the State Records Center returned under the legal control of the Vermont Department of Health and recording volumes of vital events reported to the Secretary of State between the years 1857 and 1968 were accessioned into the Vermont State Archives.

2019: Vermont Statewide Registry System

Pursuant to Act 46 of 2017 and effective July 1, 2019, all birth and death records dating January 1, 1909 and later are only available through the Department of Heath's Statewide Registry System. Original source records for these events in the offices of the town clerks and the state registry are available for informational research purposes; however, the Statewide Registry System is the official system of record and certified and noncertified copies of birth and death records can only be issued through this system.

The Department of Health, all town clerks and the Vermont State Archives and Records Administration are authorized by law to issue certified and noncertified copies from the Department of Heath's Statewide Registry System.

INSTRUCTIONS.

In the preceding Act, the Secretary of State is charged with the executive duty of providing for the collection of the vital and mortuary statistics of the State of Vermont, and by the official aid of the Medical Profession, of arranging and publishing such statistics, in a manner which shall best subserve the benevolent purposes designed by the Statute.

In fulfilling the requirements of this law, the people of Vermont are only following a few years behind the best regulated governments in Europe, and in many States of our Union; which, without exception, have been constantly stimulated to increased efforts for the improvement and faithful execution of Registration Laws, by the great and unexpected advantages already derived from them.

The additional duties of the officials named in this act, therefore appeal to their public interest, as well as fidelity, in taking the first steps in an important public and philamthropic measure. Vigitance in looking up all the required statistical facts which occur in each sphere of duty; an accurate and truthful record of them, and punctual tilty in returning the forms to the superior executives, only, will accomplish the intentions of the law. Town clerks will be expected to exercise a general supervision of Registration in their several towns; by giving a general notice of the law by reading it in the next annual town meeting, by explaining the statute and instructions if necessary, to the district clerks, the calling the attention of clerks, clergymen and physicians to omissions, in accuracies or delinquencies of their returns, and enforcing their penalties.

The Town Clerks are particularly desired to see that the district clerks in their several towns are seasonably supplied each year with the blanks for school district returns.

To Clerks of School Districts, especially in populous towns and a changing population, it is suggested that much virilance will be necessary to ascertain all the births and deaths and requisite circumstances, occuring in their precincts; and they are directed to begin their investigations at the commencement of the year, and to make their record each month consecutively; and when practicable to state "the apparent case of death" up. n. information derived personall

Above: The text of Act No. 63: An Act Relating to the Registry and Returns of Births, Marriages, and Deaths, approved on November 17, 1856, and amended with Act No. 33, approved on October 30, 1857. Followed by the instructions to Vermont town clerks by Charles W. Willard, Secretary of State. This could be found on the inside of the front cover of the oversized volumes that were supplied to towns in 1857. Originally the covers of these volumes were a greenish-blue cardboard with brown leather binding strip, and the pages printed on blue paper. In 1859, a more detailed set of instructions was published in pamphlet form by Benjamin W. Dean, Secretary of State, entitled: Instructions Relative to the Registry and Return of Births, Marriages and Deaths, in Vermont. (Middlebury: Register Book and Job Office, 1859). Barbara Mae (Bullock) Jones 1934 – 2020

Barbara Mae Jones passed away peacefully on Christmas Day in Burlington, Vt., at the age of 86.

She was born in 1934 in Springfield, Mass., to Lt. Col. Charles L. Bullock (USA Ret.) and Mae Ende Bullock. She resided in Springfield until graduating college, except for a short time when the family lived in Washington, D.C., during World War II.

She obtained a B.S. in Home Economics at the University of Massachusetts Amherst and accepted a teaching position at Auburn (Mass.) High School soon after graduating. While working, she earned a M.S. in Education from the University of Connecticut at Storrs.

While at UMass, Barbara represented the Student Christian Association at a national meeting at the University of Kansas, where she met her future husband, who was representing the University of New Hampshire. Barbara married Col. Warner Jones, M.D. (USAFRES Ret.), in 1960 and they moved to Charlestown, N.H., in 1968. She began a second career managing doctors' offices for physicians practicing at Springfield (Vt.) Hospital.

She had a significant impact on the town of Charlestown during her 35 years as a resident. Active in the community, she was a founding member of the Charlestown Women's Club (part of the GFWC of NH), Trustee of Old Fort at No. 4 Associates, Historian of Fort at No. 4 and Trustee of the (Charlestown) Trust Fund. She was active in numerous associations and groups, including Crown Point Road Association and Society, in addition to serving on school committees and volunteering as a Cub Scout and Webelos leader. In 1985, she was recognized as one of New Hampshire's Outstanding Volunteers.

Barbara participated actively in genealogy and historical societies and wrote a historical column for The Walpole (N.H.) Gazette.

When time permitted, she enjoyed traveling in Europe, the United Kingdom, Scandinavia and Canada.

Barbara took great pride in her three sons: Charles, Warner and William, and loved interacting with her nine grandchildren: Ethan, Caleb, Sadie, Zachary, Connor, Delaney, Maxwell, Emily and Timothy.



To the end, she was sharp as a tack, although declining health restricted her ability to continue reading, writing, researching and sharing her knowledge of history. She will be remembered lovingly by her family, friends and caregivers.

A private ceremony will be held in the spring for her internment at the N.H. Veterans Cemetery, and -- pandemic permitting -- a memorial service will be planned in Charlestown, N.H., to celebrate her life.

Reprinted from the first editions of 1908 and 1902, this is an important source of one of Vermont's oldest towns. The town records extend to 1845 and church records from 1773 to 1839. New to this edition is an index of nearly 1,000 names.

Georgia, Vermont Vital Records. Peter S. Mallet, ed., 1995, hardbound. Item No. GSV 4; Sale Price \$15. This volume presents all births, baptisms, marriages, deaths and burials recorded in the town. All the civil books were transcribed as well as the records from the Georgia Plains Baptist Church, Congregational Church, and Methodist Church of Georgia and North Fairfax.

Windsor County, Vermont Probate Index, 1778-1899. Scott Andrew Bartley and Marjorie-J. Bartley, compilers, 2000, 560 pp., hardbound. Item No. GSV 6; \$45.00 members, \$50.00 non-members. This is a comprehensive index of all files in the Windsor County Probate Court Districts —Windsor and Hartford. The records cover the period from the earliest 1778 records through the end of the nineteenth century, more than 20,000 probate files. The files are indexed by the name of the major party in the case, place of residence, probate district, type of record, year, and probate record volume.

Index to Branches & Twigs, 1972—1995. Robert M. Murphy, ed. 2000, 572 pp., hardbound. Item No. GSV 7; Sale Price \$20. This is the every-name index to GSV's Branches & Twigs, published for 24 years in 96 issues. The 180,000 entries include every genealogically important name mentioned in every issue. Separate sections of this work list the coverage of each Apple Orchard installment, and provide a full author and title index to book reviews. Branches & Twigs included large quantities of information of interest to family historians.

Sudbury, Vermont: Genealogies, Vital Records, and Census Records. Mary Ann Z. Wheeler, 2000, 416 pp., hardbound. Item No. GSV 8; **Sale Price \$20**. This book is a comprehensive transcription of census and vital records for Sudbury, plus carefully compiled genealogies of families. This book is among the very best genealogical resources about a Vermont town. This is a cooperative publication between GSV and Picton Press.
