PRESIDENT'S MESSAGE

Wishing everyone a Merry Christmas and a Happy New Year. The holiday season is a time for reflection upon family and many times we are lucky enough to be able share our newfound genealogical discoveries.

GSV's fall membership meeting on October 29, 2016, was held at the Franklin Conference Center at the Howe Center in Rutland, and was certainly enjoyed by those who attended. Using the information provided during the talk by Mariessa Dobrick, CA Archivist II VSARA, GSV's treasurer Jane Belcher was able to find some very interesting information on her second great grandfather, a patient of the Brattleboro Retreat. Jane received 4 pages of records about her ancestor, Moses Bohannon of Alburgh, a patient from his admission 4 September 1884 until his death, on 9 January 1886. The records provide insight into how his admission came about. Here is how to access the form to request the records if you had an ancestor who was a patient. Go the Brattleboro Retreat's website www.brattlebororetreat.org and click on admissions. There you can then access the "Protected Health Information

Release Form." Simply download the PDF file, print out and complete the requested information and mail to the address provided. This is an under-utilized genealogical resource, and we thank Mariessa for bringing this to our attention.

Vermont Vital Records Card Index Error

While researching the Whitcomb family, I found something curious regarding a branch of family in Springfield. According to the Vermont Vital Record Card Index, there were two children are born to William L. and Matilda L. (Kirk) Whitcomb during the year 1864, only a little more than two months apart. The first child was Estella Matilda Whitcomb, born in Springfield on 12 September 1864, followed by a second child Leonard Ansel Whitcomb on 24 November 1864. William was born in Townshend and Matilda was a Springfield native. Images of the cards are provided below. However the vital records at the town level state that Leonard is the son of Peres and Mary (Bates) Whitcomb. [Springfield, Vt., Vital Records, 5: 68] A section of that page is found below, the births referred to are No. 29 and No. 40. So what happened? It seems that Samuel W. Porter (1792-1882), Springfield Town Clerk from 1848 to 1881, made an error when he wrote down the birth of Leonard, in error giving the parents of Matilda. This error is found in the original vital record book for this period [Springfield, Vt., Vital Records 1857 to 1867: 31], and that was the information that was sent to state. The 1857 to 1867 vital records were copied into the subsequent volume that started in 1868, with the error. However, Leonard died in Springfield on 23 March 1869, of whooping cough, and his correct parents were given. [Springfield, Vt., Vital Records, 5: 181] It was probably at this point it was realized that there was an error in the 1864 birth records and the entry in volume 5 was erased and corrected. However the birthplace of the father was not changed, as the actual birthplace of Peres Whitcomb was Springfield and William's was Townshend. This is a case of an error that was made at the town level, then sent to the state level, and was subsequently (mostly) corrected at the town level, but not at the state level.

BURLINGTON - Eleanor Angell died peacefully on Nov. 28, 2016, at her home in Burlington, Vermont. Eleanor was born on July 5, 1923, in Schenectady, New York, and attended seven schools through grade 12 (Schenectady and Albany, New York, and Burlington). Eleanor graduated in 1942 from Milne School in Albany and in 1946 from Rensselaer Polytechnic Institute, Troy, New York, with a B.S. in Chemistry. She was one of only six women who graduated with degrees from RPI that year. Eleanor worked from 1946 to 1984 in the Analytical Chemistry Department of Sterling-Winthrop Research Institute, Rensselaer, New York (the research branch of Sterling Drug Inc.). Beginning in the 1960s, her work increasingly consisted of preparing chemical and manufacturing information for new drug applications, and she held the position of group leader of the Technical Writing and Auditing Group for 14 years. In June 1984, Eleanor moved to Burlington and became involved with genealogical research and the family history of her Vermont ancestors and their extended families. In 2000, after 12 years of research, Eleanor published the book, *Three Early Vermont Settlers: Amos Morse, George Trow, and Ephraim Ainsworth*, which explores the genealogy of the three settlers, their American ancestry and many of their descendants through several generations.

Eleanor was an enthusiastic member of many groups and organizations, including the Hardwick Historical Society, Vermont Historical Society, Genealogical Society of Vermont, Vermont Old Cemetery Association, Thomas Angell Family Association, New England Historic Genealogical Society, Daughters of the American Revolution, American Chemical Society (emeritus) and the United Church of Hardwick. In accordance with Eleanor's wishes, there will be a graveside service in the spring at the family plot in the Main Street Cemetery in Hardwick, Vermont. Windsor County, Vermont Probate Index, 1778-1899. Scott Andrew Bartley and Marjorie-J. Bartley, compilers, 2000, 560 pp., hardbound. Item No. GSV 6; \$45.00 members, \$50.00 nonmembers. This is a comprehensive index of all files in the Windsor County Probate Court Districts —Windsor and Hartford. The records cover the period from the earliest 1778 records through the end of the nineteenth century, more than 20,000 probate files.
