VERMONT DIVORCES 1925-2003

The Vermont Vital Records Card Index of births, deaths, and marriages can be easily searched on several websites. However the FamilySearch collection entitled "Vermont Vital Records 1760 to 2008," also contains browse only images of divorce records between 1925 and 2003. CALEB E. BARTON FAMILY BIBLE

GSV was contacted about a Vermont Bible by Stanley Diamond, President, Jewish Genealogical Society of Montreal www.igs-montreal.org and Executive Director, Jewish Records Indexing - Poland, Inc. www.iri-poland.org. He contacted us on behalf of his friend Carol Abramson, whose mother-in-law purchased this Bible in an antique shop in the Montreal area around 30 years ago. She is hoping that a Barton and(or) Langdon descendant can be found, so it can ultimately be returned to the family.

The Bible of the family **Caleb E**. and **Betsey (Powell) Barton** residents of Charlotte, Chittenden Co., Vt., was published (Utica, N.Y.: John W. Fuller & Co., 1856) and includes the following information:

MARRIAGES.

Caleb E. Barton and Betsey Powell were married May 20^{th} 1823

BIRTHS

Caleb E. Barton Born May 30th 1794
Betsey Powell his Wife Born March 2nd 1801
Ann Elizabeth Born August 21st 1825
Edward J. Born Feb. 19th 1829
Henry J. Born December 27th 1830
William Powell Born May 4th 1833
Lucius Caleb Born Dec. 24th 1835
Joseph Gilbert Born Sep. 6th 1838
Rollin Williams Born February 27th 1841
Helen Marion Born August 29th 1843

DEATHS.

Edward J. Died March 1st 1829 Lucius C. Died May 25th 1861 Betsey (Powell) Barton Died June 4th 1868 Caleb E. Barton Died June 29th 1877 Ann Elizabeth Langdon Died April 19th [blank...] William P. Barton Died May 29th 1919 William Wallace Langdon Jr. August 7-1958. Burial Aug. 10.

The last three entries are in different hand and ink.

The Bible also includes an envelope with religious items and a ticket to the Champlain Valley Agricultural Society, which was organized in 1857 in Vergennes, for farmers in upper Addison and lower Chittenden Counties. It is a "Complimentary admission for W.W. Langdon and lady for September 26, 27, & 28, 1882."

Editor's Note: The birth of Caleb E. Barton is included in a family group record of the children of Jeremiah Barton and his two wives Hannah (Williams) Barton and Anna (Grant) Barton. [Charlotte, Vt., Town Records, 2: 522] Ann Elizabeth Barton, daughter of Caleb E. and Betsey (Powell) Barton married William Wallace Langdon in Charlotte, on 7 January 1846. [Charlotte, Vt., Town Records, 3: 129]. The will of Caleb E. Barton, dated 30 October 1876 gives and devises to his son in-law William W. Langdon and daughter Ann Elizabeth Langdon all his real estate together with the farming tools and household furniture. [Chittenden Co., Vt. Probate (Estates) Box 25 File 3537]

ELEVATING GENEALOGICAL EDUCATION

The Salt Lake Institute of Genealogy is pleased to announce that several scholarship opportunities are available for students planning to attend the Salt Lake Institute of Genealogy (SLIG) in January 2017.

ASG Scholar Award, American Society of Genealogists – Deadline August 31, 2016

This award provides "financial assistance for a developing scholar to attend one of five academic programs in American genealogy."

The Genealogy Fairy – Genealogy Grants Program – Awarded monthly

This program, created by Thomas MacEntee, gives "back to the genealogy community through a series of grants to organizations and individuals . . ." Awards up to \$500 are given for qualifying projects, including genealogy continuing education programs.

New SLIG Scholarship Fund – Deadline October 1, 2016

This fund, opened at SLIG 2016, was created to enhance scholarship opportunities for SLIG students. This year's award will provide partial tuition to a transitional genealogist attending an institute for the first time.

Further details about scholarship opportunities may be found at slig.ugagenealogy.org.

The 22nd annual institute will be held at the Hilton Salt Lake City Center Hotel, January 22-27, 2017. Fourteen courses of in-depth study on a wide array of genealogical topics, including methodology, geographical specialties, special topics, and technology are being offered to help students "elevate [*their*] genealogical education to new heights"! All courses are taught at an intermediate to advanced level; detailed course outlines and prerequisites will be posted online as they become available.

Registration fees include selection of the course of choice (based on availability at the time of registration), participation in special events such as the reception and banquet, networking opportunities, and time to research at the nearby Family History Library.
