first speaker, and will include the biennial election of officers. This meeting will include a membership vote on the addition of the Past-President to the Board of Directors. The position of GSV Past-President has long been considered part of the GSV Board of Directors. However this was never written into the GSV's By-Laws, adopted in 1994 and subsequently revised in 2002 and again 2007. Therefore the Board proposed a revision to the By-Laws, to add the wording "and the Past President" to Article IV (Board of Directors). Article IX (Amendments) sets the criteria for revision of the By-Laws at the annual business meeting after adequate notification in the Newsletter. This was done in the March 2016 GSV Newsletter, as amendments have to be distributed to the membership at least one month prior to the annual business meeting in the fall. **BENNINGTON** – **Kirt Allard Adams** passed away in Lafayette Hill Pennsylvania on July 18, 2016 with family and friends around him. He was 94. Kirt was born on July 4, 1922 in Rutland, Vermont, the son of Kirt West Adams and Ella (Gray) Adams. The family moved to Bennington, Vermont in 1924. Kirt graduated from Bennington High School in 1940, where he was a member of the band and pro merito. He completed his AD in business at St. Joseph's in Bennington in 1941. Prior to his entry in World War II he worked at the County National Bank.

Kirt entered service in the Army Air Corps in January 1943. He was attached to a Fighter Control Squadron in the European theater for most of the war, but also served as a chaplain's assistant in France and Germany. In 1946 he returned to Bennington with the rank of Sergeant. Kirt used his GI bill to improve his business education, taking courses in time motion study. He entered industry in Bennington in middle management. During this time he became reacquainted with Barbara F. Morgan of Pownal, who was teaching high school English. They married on July 20, 1947, and remained happily married for 67 years, until her death in 2014.

Barbara and Kirt lived in Bennington and Pownal until 1952, when EZ Mills left Bennington for Georgia. They decided to move instead to Pennsylvania for a similar position, as it was closer to their Vermont roots. They raised their family in Pennsylvania, living in Eagleville and Audubon Pennsylvania until five years ago, when they moved to the Masonic Village in Lafayette Hill. Kirt worked for many years for Lees Carpets, a division of Burlington Industries, first in Bridgeport, PA and later Audubon, PA. His final title there was data base analyst.

In retirement, Kirt and Barbara enjoyed a second home on Lake Blaisdell in South Sutton, New Hampshire, near their New England family. More recently, they were summer residents in South Ryegate Vermont, near their daughter and eldest son and their families.

Kirt had a musical gift and was a fine violinist. He had a strong Methodist faith which sustained him throughout his life. He had a calm, quiet personality and was known as a peacemaker. He attained his 70th birthday as a Freemason, and was a longtime member of the Warren Lodge in Collegeville, Pennsylvania. He attained the 32nd degree and attended the Allentown Consistory. A student of American history, he was a member of the Mayflower Society of Descendants, SAR, and the Society of the Descendants of Valley Forge. He was also a lifelong stamp collector, and served as auditor for his club's books for many years.

Kirt was the only child of his father's second marriage, and is the last of a long generation. He is survived by his three children: Kirt W. Adams and wife Joanne of North Danville, VT; Peter M. Adams and wife Karen of West Chester, PA; and Carolyn L. Adams, Esq., of South Ryegate, VT; five grandchildren, Chloe M. Adams of Saint Louis, MO; Aurora M. Adams of Lexington, KY; Carolyn J. Adams, Jacob M. Adams and Mary Elizabeth Adams, of West Chester, PA; many cousins, nephews, and nieces, with special mention of his niece, Diane Adams Poland of Metairie, LA.

A private committal service in Park Lawn Cemetery, Bennington VT, was held in August.

**NORTH SPRINGFIELD – Marjorie J. Bartley**. Marge, wife of Leonard M. Bartley, died at the Springfield Health & Rehab Center on Sunday Aug. 7 at age 81.

The daughter of Hyland R. and Bernice I. (Olney) Lamphere, Marge was born in West Burke on May 26, 1935, while her father was serving at Camp Willoughby in the Civil Conservation Corps. She grew up and lived most of her life in North Springfield, where her mother's family had lived since the 1780s. She was a life-long, active member of the Advent Christian Church, where she married her husband on May 5, 1953.

Marge went to the North Springfield Graded School and graduated from Springfield High School in 1953. She moved with her husband to Fredericksburg, Va. while he served in the Marines during the Korean War. They moved back to their childhood home in North Springfield where they spent the rest of their lives.

She worked at the National Survey in Chester until her first child was born. After the children were old enough, she went back to work at Simmons Precision in Bellows Falls and retired from there as manager of the stockroom. She loved to sing in the church choir, read, play card and board games, travel far and wide and spend time with her extended family.

She is survived by her husband of 63 years; son Larry and his wife, Linda Corliss, of Springfield; son Scott Andrew (Drew) and his husband, Christopher Norris, of West Roxbury, Mass.; grandson, Ty Corliss, of Springfield; brother, Ernest "Puggy" Lamphere, of Springfield and half siblings Bradley Morgan of Springfield and Denise Smith of Weathersfield.

She was predeceased by her son Alan in 1960 and siblings Ervin Lamphere, Francis Lamphere and Dean Lamphere.

#### **Featured Speakers**

#### Gary Shattuck: "Insurrection, Corruption and Murder in Early Vermont"

During America's Early Republic, the pastoral villages and forests of Vermont were anything but peaceful. Conflict raged along the Canadian border, as international tensions prompted Thomas Jefferson to ban American exports to France and Great Britain. Some Vermonters turned to smuggling. Federal seizure of a boat called the Black Snake went deadly wrong—three men were killed that day, and another died later in the state's first execution by hanging. The outbreak of the War of 1812 brought thousands of troops, along with drunkenness, disease and a general disregard of civil rights, including the imposition of extra-legal military trials.

Gary Shattuck served over three decades in the Vermont law enforcement community with the Vermont State Police, as an assistant attorney general and assistant United States attorney with the U.S. Department of Justice where he also served as a legal advisor to governments in Kosovo and Iraq.

A graduate of the University of Colorado and the Vermont Law School, Gary recently received his master's degree in military history concentrating on the Revolutionary War. He is a regular contributor to Army History magazine and the Journal of the American Revolution. His most recent research has revealed the presence of a huge opium and morphine addiction problem in Vermont in the nineteenth century and his findings were recently published by the Vermont Historical Society. His third book describing the situation further will be published by The History Press in 2017. Gary's second book, Insurrection, Corruption and Murder in Early Vermont, concerning the devastating effects of Thomas Jefferson's Embargo of 1807 on those living in northern Vermont forms the basis of this presentation.

#### Margaret R. "Peggy" Jenks: "Is That What it Said? That Can't be Right. What is correct?"

Many genealogists rely on information that they find online, that appears on sites such as Ancestry.com and findagrave.com. But how reliable is that information? Does the data even make sense? Peggy Jenks, will provide examples comparing this material with original sources. You will be surprised how many errors she has uncovered.

Margaret R. "Peggy" Jenks has been a family genealogist since 1964 and a cemetery transcriber since 1978. She has published award-winning books listing all the cemetery inscriptions of the twenty-seven towns in Rutland County, Vermont, and of Granville, Washington County, New York...over 225 cemeteries in all. She is also researching the many carvers of Rutland County stones.

Peggy is the author of the three-volume Descendants of Thomas Horton of Milton and Rehoboth, Massachusetts, and many others. She chaired the Seattle Genealogical Society's Computer Interest Group from 1982-1986, was editor of the Genealogical Society of Vermont Newsletter from 1996-2005, and served six years as a trustee of the Association for Gravestone Studies. n June 2014, Peggy was awarded the 2014 Harriet Merrifield Forbes Award, the highest honor bestowed by the Association for Gravestone Studies, for her distinguished service in the field of gravestone studies. She is currently researching her children's ancestry in newly published records that correct many previous errors.

#### Mariessa Dobrick, CA Archivist II VSARA: "On the Road to Your Family History"

Genealogists are familiar with using vital and probate records to trace ancestry. But did you know that the Vermont State Archives has a wide range of other records that can be useful for family history research? Vermont State Archives archivist Mariessa Dobrick will be providing not only an introduction to records beyond the usual resources for genealogical research, but will also highlight some of the stories gleaned from records.

Mariessa Dobrick has been an archivist at the Vermont State Archives and Records Administration (VSARA) since 2011. Prior to that, she worked at the Wisconsin Historical Society in Madison, Wisconsin. Mariessa holds a Bachelor of Arts in French and a Master of Arts in Library and Information Studies with a certificate in Archives and Records Administration from the University of Wisconsin-Madison. An avid genealogist, she delights in helping researchers find their own family stories, sometimes in unexpected places.

# Directions to the Franklin Conference Center at the Howe Center, Rutland, Vt. One Scale Avenue, Building # 3:

#### **From The North**-(i.e. Burlington Vermont)

Take U.S. Route 7 south to Rutland. Turn right onto Madison Street when you see Christ the King church on your left. Turn left at the traffic light at the bottom of the hill. Howe Center is on the right about two blocks down. Park in the outer lot or pass through the tunnel to park in the interior courtyard. The Conference Center is located in Building #3 which is on the right side of the tunnel as you drive into Howe Center

#### From the North east and East-(i.e. Montpelier, Vermont)

Take Interstate 89 south to Exit 3 for Rutland. Turn right at the bottom of the exit ramp. Follow Routes 12/107 and 100 to route 4 west in Killington (about 20 miles). Take Route 4 west into Rutland and turn left onto Route 7 South. Follow above directions from there. When coming from the east take Route 4 west into Rutland, then turn left onto Route 7 South.

#### From The Southeast- (i.e. Massachusetts)

Take Interstate 91 north to Exit 6 for Route 103 North. Route 103 exits onto Route 7 about 3 miles south of Rutland. When in Rutland, take a left at Dunkin' Donuts onto Strong's Avenue. Howe Center will be on your left about two blocks down.

#### From The West-(i.e. New York State)

Take Interstate 87 north to Exit 20 and turn onto Route 149 east of the Village of Fort Ann. Turn left onto NY Route 4 heading north. Follow to Route 4 North about 12 miles into Whitehall NY. Bear right in Whitehall Village to take U.S. Route 4 East into Rutland. At the end of Route 4 take a left onto Route 7 north. Go approximately 1-2 miles and Dunkin' Donuts will be on your right. Turn left onto Strongs Avenue. Howe Center will be on your left about two blocks down.
