Town Clerk of the Year Award Prominent newspaper publicity in the *Bennington Banner* honored 1998 recipient Judy Stratton of Shaftsbury and gave GSV a boost as well. Nominations for the 1999 award will be happily received by the Board at any time.

Access to 1955-1978 Vermont Vital Records Your officers have communicated with Thomas Torti, Commissioner of the Department of Buildings and General Services for the State of Vermont, about this concern. Briefly, between 1955 and 1979, applicants for marriage licenses were asked a number of questions about such matters as race, marital history, and education. Their answers to these questions were to be used for statistical purposes only and not become part of the

public record. Through oversight, when vital records of this period were microfilmed for public access at the Public Records Division in Middlesex, some of these "confidential" responses were filmed with them. This renders the entire body of vital records from this period inaccessible except with staff assistance. If you want a vital record from the 1955-1979 period, you have to ask a staff person to find it on the film, make a print, and give that to you, and you will be charged on a perrecord basis for this.

Obviously, this is unacceptable to a researcher who is interested in viewing numerous records from this period. Commissioner Torti and his staff realize this and hope to have the necessary funding through a special appropriation in 1999 to re-film the records without the offending "confidential" material.

Our discussion about this problem has been cordial, and we hope it will be productive. The appropriation necessary to carry out the necessary re-filming will be included in legislation before the 1999 session of the Vermont Legislature, and if it appears that lobbying of individual legislators -- for example members of involved Legislative committees -- is worthwhile or necessary, you will be notified. In the meantime, repeated pestering of Commissioner Torti and his staff about this situation will not be productive. They have a job to do and laws to obey, and we will try to make it possible for them to do so while emphasizing to them that access to these records is important to us.

Records Preservation Grants Program GSV has offered up to five mini-grants yearly to individuals and organizations for assistance with preservation and dissemination of records of potential interest in the study of Vermont family history. We are pleased that the maximum amount for each of these grants has been raised to \$1000. Contact any officer for more details on how to apply.

Microfilming of WPA town record inventories With much encouragement from Alden Rollins and financial support from GSV, the Public Records Division is microfilming the unpublished inventories of town records prepared by the WPA Historical Records Survey in the late 1930s and early 1940s. These inventories generally contain a well-written capsule history of the town and a thorough inventory of the town records which existed at that time. (Some have since disappeared.) The condition of the originals is such that filming is a useful preservation effort. Copies of the film will be available at Public Records and at such libraries as the Vermont Historical Society.

New England Regional Genealogical Conference The October 1998 conference in Portland, Maine was a success, and GSV met many people interested in Vermont genealogy at our booth. The May 2000 conference in Providence. Rhode Island, combined with a large national conference of the National Genealogical Society, promises to be quite a blockbuster. Planing is already well underway. and anyone interested in assisting with committees -- Local Arrangements, Volunteers, On-Site Registration, Hospitality. Local/Regional Publicity, Program, Computer, Syllabus, Signs and Audio-Visual. Societies. Photography. Participating

BRANCHES AND TWIGS INDEXING PROJECT OFF AND RUNNING

After months of talk and planning, the Branches and Twigs Indexing project has at last begun. Being a "new cucumber", so to speak, on the GSV Publications Committee, yours truly was fingered for the job of spearheading this project. And I, being green and innocent, agreed to the assignment.

Several months went into an on-line discussion of guidelines to use for the index, and although some would have liked to see a more elaborate treatment, we decided in the final analysis to keep it simple. The index will include all names listed in the 24-years' worth of issues, with some exceptions: (1) Apple Orchard entries, (2) contributors and book reviewers, (3) authors and publishers, (4) names mentioned in connection with GSV business and (5) casual historical references. Each index entry will include a person's name and a volume and page reference. Married women will be listed by both their married and maiden names if known.

There was some consideration given to including a geographic and/or date reference for each person as well, but it was felt this would greatly complicate the indexing process and the idea was dropped.

Although some may regret the decision to exclude from the index those names included in the Apple Orchard feature, please be assured that the final publication of the index will include a special section identifying in which issues one may look for specific alphabetical entries for this feature. Another special section in this publication will be an index to book reviews by title and author.

During the past year or so, many GSV members have indicated an interest in helping out with this project. In September, a letter was sent to all who had expressed an interest, asking about their continued interest, and advising them of the computer requirements associated with the software which was selected

(SKY Indexer). Responses to this mailing resulted in a final list of 12 indexers.

Software was purchased in early November and forwarded to indexers with instructions and initial assignments. To the extent possible, all correspondence and submissions will be by e-mail. That will result in some of us (including yours truly) learning a lot more than they do now about file transfers, conversions, etc. Questions about the process have already started coming in, and responses are being provided simultaneously to all indexers, so that we may all be privy to all discussions about the project.

As part of the initial package to indexers, a "practice sheet" was developed that all were asked to complete before beginning their first issues. That is proving to be a valuable learning tool, and is an opportunity to ensure that we all understand expectations before undertaking the indexing of an entire issue. Some indexers are already at the point where they are ready to move on to the actual work of their first issues.

I have established no time for this project to date, preferring instead to let indexers learn and proceed at their own individual paces, and see how progress goes in these first few months. Once we have an idea how quickly indexing will proceed, it will be possible to project a completion date for the total index. Based on the results of working with the relatively simple "practice sheet", it looks like the final product will be mammoth in size!

Lineage books of members and DAR applications.

Thousands of typescript volumes with family, church, cemetery and town records from all over the United States.

Finding aids for using unpublished material in the collection.

Analytic index for books, periodicals and for special projects.

Your editor has spent many days at the above repositories doing the past thirty years. Don't expect to walk in and find everything you want at once. It takes time to find your way around each of the facilities. For some records at the National Archives, you may have to place your request the day before. Census records are filled by year, then alphabetically by state. Revolutionary War Pension records are filed alphabetically. You help yourself to one roll of film at a time. Good hunting.
