We are working on the technology of incorporating our membership directory, including family names people are researching, on the site, with access to that information limited to members. (At present, as you know, this is available in a printed publication, but the use of the Web site would permit us to update it more regularly.) We will need to know if any members currently listed in the published version of the list would not want their names and other information on a members-only section of the Web site. We also plan to include queries submitted to *Vermont*

*Genealogy* on the site; again, if submitters of queries do not want them on line, they need to let us know. (This reminder will be published in *Vermont Genealogy* with information about submitting queries.)

#### Other things we've been up to

GSV has provided financial assistance to the Congregational Church of Middletown, Vermont, in microfilming of its early records; copies of the film will be at the Vermont Historical Society, the Congregational Library in Boston, and elsewhere. We are also assisting the library at the Bennington Museum (generally recognized as the second ranking Vermont genealogical library after the Vermont Historical Society) in acquiring and maintaining microfilms of the Vermont vital records index. We continue to be interested in proposals for preservation or publication of genealogically important Vermont records which are not as accessible as they should be in their present form.

#### *Vermont Families in 1791*

Scott Andrew Bartley, editor of this award-winning series, reports that there is progress toward publication of Volume III. Contact him if you have submitted material which needs additions or corrections before it is published.

#### Vermont Historical Society

The VHS library will be closed until late spring of 2002 as it moves to the former Spaulding School building in the center of Barre. Patrons will be pleased by the expansion of space and facilities at the new location. Many of you will hear from VHS about its ongoing capital campaign to raise funds for this new facility. This campaign has been very successful so far but will still need strong support from any and all Vermont history enthusiasts.

#### Vermont History Expo

Sponsored by the Vermont Historical Society, this annual weekend event at the

Tunbridge Fairgrounds has quickly become one of the most popular events on the Vermont calendar. The 2001 Expo included expanded genealogy space, where GSV's representatives met hundreds of interested visitors. Dozens of local historical societies showed off artifacts and interesting information about their towns. We expect this to be an ongoing event, and GSV will continue to participate. Watch for more information about the June 2002 Expo.

## BARRE TOWN CEMETERIES COMPLETE

Transcriptions of all known tombstones in Barre Town were completed this year. The final cemetery to be done was St. Sylvester's Cemetery, located on Websterville Road, right across the street from Wilson Cemetery.

St. Sylvester's cemetery was established in 1916, and is the site of many Roman Catholic burials. Prior to the establishment of this cemetery, Catholic burials in Barre were in St. Monica's Cemetery, now in Barre City, and before that, in St. Augustine's in Montpelier. The index for this cemetery contains 2909 entries, so it is a significant source of information on Barre Town burials.

### SPRING VOCA MEETING

The spring meeting of the Vermont Old Cemetery Association is planned for Saturday May 4, 2002.

Are your VT ancestors buried in an abandoned cemetery? Have you found their stones in bad condition? Get a group of citizens together and have a clean-up day.

VOCA offers a grants to anyone interested in restoring an abandoned or neglected cemetery, both public and private. VOCA will reimburse an applicant for up to \$500 for repairs where the work is done by volunteers. (Volunteers do not get paid.) If the work is done by contract or hired labor, VOCA will reimburse the applicant for two-thirds of the cost up to a maximum of \$500. VOCA does not subsidize fencing and cleaning. By law, towns are responsible for the erection and maintenance of fences, and mowing of grass, weeds and brush in town or public cemeteries and, by petition, may be required to take over private cemeteries that are not maintained. VOCA also runs workshops on restoration of monuments and cemeteries.

### CONFUSED ABOUT THE TERMS CONSORT AND RELICT FOUND ON OLD GRAVE STONES?

Consort means spouse, usually referring to a wife who had died and left a husband, but in rare instances referring to the husband. Think of Queen Victoria's husband, known as "prince consort". Relict is another word for widow.

In the Rutland County probate records the word "intermarried" refers to a widow who has remarried and is settling her deceased husband's estate as the wife of another man.

## GEORGIA, VERMONT VITAL RECORDS
